1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Samaj Shikshan Mandal Amruteshwar Arts, Commerce and Science College is the only college in entire Velhe Tehasil imparting higher education to the students of remote and hilly area. This college proved its relevance as it benefited a greater number of girl students. Prior to establishment of this college girl students were getting married at tender age. After establishment of this college the number of graduated girl students have increased sizeably. The College has alumni Association. This Association was working since passed out first batch informally. In alumni association 23 batches of Arts faculty, 10 batches of commerce faculty and 7 batches of Science faculty are active. However, it is registered recently. The parents of the students of college are either agriculturist or agricultural laborers. The institution is run by the parent organization Samaj Shikshan Mandal Vinzar. The parent organization believe in the ideology which reflected in its statement "Sarva Shreshth Dan Vidyadan" i.e. "Imparting Education is the Best Form of Donation". The Parent organization Samaj Shikshan Mandal was established in 1961 and registered in 1982.

The parent institute is association registered under Public Trust Act and working with social responsibility and democratic values. The parent institute recruit best teachers with proper recruitment policy directed by Savitribai Phule Pune University, Government of Maharashtra and UGC.

The institution Amrtueshwar Arts, Commerce & Science College was started in 1997 with "Arts' as single faculty on 100% grant in aid basis followed by Commerce faculty in 2010-11 and Science faculty in the year 2013-14. The institution was first accredited in 2004 with 'C+' grade by NAAC. The second cycle of NAAC accreditation was completed in 2016 with 'B' grade.

The institution is permanently affiliated with Savitribai Phule Pune University. The college has received 2F 12B recognition by UGC.

Since the inception, the institution has clear vision, Mission and objectives set as fundamental pathway. The college celebrated its Silver Jubilee in the year 2022.

Strong research culture is also one of the prominet part of the college. 74 % staff i.e. out of 19 permanent teaching staff 14 are Ph. D. holders and remaining all the faculites have complited their M.Phil qualification. Faculites contribute in desing development and implementation of curriculum in Board of Studies of an affiliating university.
- 3. Assessibility is one of the imporatant strength of the institution. The institution is situated at the center of the Velhe tahsil with direct proximity to road.

- 6. Effective implementation of the Co-curricular and extra curricular activities for the students.
- 7. Well equiped central library with more than 4000 books enriched with more than 100 eference books, dictionaries and encyclopedia.
- 8. The institute serves as only higher education center of Hilly and Remote Velhe Tehsil.
- 9. The institue could become information and devlopment center of Velhe Tehsil in near future.

Institutional Weakness

- 1. Industrial backward region- As institute in situtated in remote hilly area, student have no oppurtunity of expreimental learning in industries. In wake of industrial backwardness of the region, students have no oppurtunity of recruitment in vicinity of their area through campus interview.
- 2. Institution lack revenue generation. The institution is getting no other grant from the government other that salary grant. Institution is sloly dependent on the revenue from fee collection and donations from the society.
- 3. As all the students are from the farmers family very less studetsn are pursuing higher education. The drop out rate is also quite high from first year to last year.
- 4. Involvement of Alumni at institutional level is less as most of the pass out studetns migrate to Pune City for the job purpose. Therefore, it is also difficult to track the Alumni.
- 5. Lack of developed sofesticated infrastucture is one of the weakness of the institution as the source of income for the institution are marginal.
- 6. Lack of placement avenues is major weakness of the instituion. The area where the instituion is situated is remote and hilly area with no industry in 50 km of redius.

Institutional Opportunity

- 1. Scope for improvement of digital literacy amoungs students.
- 2. Scope for interdiciplinary and sponsored projects.
- 3. To arrange more number of FDP's / Conferences / Seminars
- 4. Institution can start need based cources for the students for their overall developement and make them industry ready.

- 1. Strengthen Industry Institution interaction. As no industry is available in the near proximity of the institution. Therefore, placement of students in core companies is challenge.
- 2. The instituiton has mroe that basic infrastructureal facilites. However, there is much more room for updating and adding to the existing infrastrucure.
- 3. Encouraging students for competitive examination and higher studies.
- 4. Industry specific training and sponsorship from the industry.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The Samaj Shikshan Mandal Amruteshwar Arts, Commerce College is affiliated to Savitribai Phule Pune University, Pune and scrupulously follows the curricula prescribed by the University. Curriculum is very essential component of an education system. Teaching-learning-evaluation, student activities and research revolves around it. The institution ensures curriculum delivery through well-planned academic programs and processes.

UG Curriculum was changed from Annual pattern to Choice Based Credit System from June 2019. It introduced more academic flexibility. Currently the institution runs 3 UG programs viz. Arts, Commerce & Science.

Faculty members participate in the syllabus up gradation and restructuring workshops. Our 17 teachers were participated in question paper setting and assessment/evaluation process at university level.

The institute adheres to Academic Calendar for the conduct of academic activity for achieving academic excellence. Wi-Fi connectivity is available in the office, Exam, IQAC and Principal's cabin and 03 classrooms are ICT enabled.

Different programs integrate cross-cutting issues into curriculum. Student-centric activities inculcate core values among students. Our 03 courses include experiential learning through project-work/field-work and internship.

Result analysis of every course is carried out to improve students' performance. The institution regularly obtains feedback on curriculum from all stakeholders.

Teaching-learning and Evaluation

The Samaj Shikshan Mandal Amruteshwar Arts, Commerce & Science College is committed for the quality education to the students of different background and abilities. The number of admitted students are increasing in every year from the last five years. The seats are filled as per the set reservation policy set by the state government and Savitribai Phule Pune University. To inculcate the higher order thinking and investigative mind various innovative methods are used by the college. The teaching process is student centric which includes experiential learning, participative learning and problem solving methodology. Various techniques used for the same are project work, participation in competition at various levels, guest lectures, role play, team work activities, debate, case studies, quizzes etc.

The number of sanctioned seats is 23, although only 19 seats are filled as no permission from the government is received.

The qualification of the teaching staff is one of the prominent strong hold as 73% of staff is Ph. D. holder. out of 19 teaching staff 14 staff members were completed the Ph. D. and remaining 5 members were completed the M. Phil.

The Internal and external evaluation is transparent. The rules and regulations are laid down by the Savitribai Phule Pune University, Pune and Maharashtra State University Act 2016. The university has also implemented IT reforms for the robust conduct of the examination. The internal marks are communicated to the students on the notice board. Internal and external marks are filled in the online system made available by the University which is time bound process. The grievances of the students are resolved by the college on priority level. The grievance form is made available by the examination department. The issues of the students are solved by the exam department and by the concerned head of the department.

Course Outcome and the programme outcome is taken care by the college. All the staff is well aware of the COs and POs and try to attain the same. Outcome based learning method is used by the staff.

College has Principal's office with adequate space and office facilities. The College has adequate facilities for cultural activities like Open-Air theatre. The college has essential facilities and equipments for various cultural activities. The college has gymnasium with required equipments. The College arranges required facilities for sports, games (indoor, outdoor). The college provides required area for indoor and outdoor sports. avail student option to opt for any subject from the faculties which are taught in the college. The college runs all the three Arts, Commerce and Science faculties. The Amruteshwar Arts, Commerce & Science College is governed by the rules of University Grants Commission, rules set by the Savitribai Phule Pune University Pune to whom the college is affiliated, and Maharashtra University Act 2016. The New choice-based credit pattern introduced by the University from the year 2019 has given the choice to the students to choose extra credit, from the various subjects offered which are interdisciplinary in nature. e.g. the election, governance and leadership is the subject from the political science, Physical education is from the subject Physical Education, Environmental awareness is from the subject Environmental science etc. are made available to all the faculties like Arts, Commerce and Science. Multidisciplinary subjects choice is not yet made available from the university by now.

2. Academic bank of credits (ABC):

The University Grants Commission, New Delhi had issued instructions to the universities for the implementation of Academic Bank Credit. The Academic Bank Credit (ABC) will digitally store the academic credit earned by students from Higher Educational Institutes facilitating students to choose their own learning path to attain degree/diploma/certificate, working on the principle of multiple entry-multiple exits as well as any time, any where and any level of learning. The ABC platrom has been developed by the National E governance Division (NeGD) of the Ministry of Electronics and Information Technology (MeitY) under the DigiLocker Framwork. The University Grants Commission, New Delhi had issued instructions to the universities for the implementation of Academic Bank Credit. The Academic Bank Credit (ABC) will digitally store the academic credit earned by students from Higher Educational Institutes facilitating students to choose their own learning path to attain degree/diploma/certificate, working on the principle of multiple entry-multiple exits as well as anytime, anywhere and any level of learning. The ABC platrom has been developed by the National E- governance Division (NeGD) of the Ministry of Electronics and Information Technology

(MeitY) under the DigiLocker Framwork. The Amruteshwar Arts, Commerce & Science College has responded promptly and quickly executed the process of opening the ABC ID of the students through DigiLocker. As the admission process is yet not complete due to extension of the University exam on the backdrop of Covid 19 situation; our college is also in the process of admission for the second last and last year students. By now college has successfully created the ABC ID of more than 250 students and send it to the University. The college is prepared for the system of National Education Policy where if any student is doing any course from other institution and that institution is made available any extra credit, the college is ready and prepared to fetch that credit of the student by requesting respective college to allot the credit. Again the academic bank credit Id number is inculcated in the admission form which is made available from this year which will facilitate the student to get the credit he has obtained from any other college.

3. Skill development:

Yes, the college has included the subjects of skill development in the curriculum for the overall development of the students. The Amruteshwar Arts, Commerce & Science College is governed by the rules of University Grants Commission, rules set by the Savitribai Phule Pune University Pune to whom the college is affiliated, and Maharashtra University Act 2016. The New choice based credit pattern has been introduced by the University from the year 2019 has given the choice to the students to choose extra credit from the various subjects. For the first year B. Com skill-based subjects like Employability and skill development which include softs skill development of the students. The college has also included the subject computerized accounting to impart the knowledge of technical skills to the commerce students. The subject like election, governance and leadership is also one subject that add value to the skill base of the student. For the last year students experiential learning is introduced in the choice based credit pattern system from 2019 it is compulsory for the special subjects like cost and works accounting and marketing where students need to take industry experience and should submit the presentation and report to the respective subject teachers.

The Savitribai Phule Pune University, Pune has introduced the Choice Based Credit Pattern System from 2019 where students are expected to go through six semesters in three years time frame. The university has been continuously carrying out reforms in its examination procedure through integration of the IT in all the procedures and processes of the examination system. Internal assessment of the students is done as per the criteria and guidelines given by the Savitribai Phule Pune University, Pune in the new choice-based credit pattern system. The marks of the internal evaluation is to be filled on the university online portal within the prescribed dates announced by the university. The college has given the choice to every individual teacher about to conduct internal assessment as per the rules and requirement of the subject.

The practical based subjects are assessed internally on the basis of practical oral assignment and problem-

solving skill of the students. Assignments are also given to them for the same. For the theory-based subjects explanative essay writing and assignment work is given and assessed.

Home Assignment, Project Work, Group discussion, Roll play, Presentation and case study methods are used for the effective internal assessment. The results are communicated to the students and also the suggestions for the improvement. Internal marks are filled on the basis of consistent internal evaluation online for every semester.

The subjects for extra credit are assigned to the specific teachers and all the teachers fill the online marks/grade for the same. The evaluation is transparent and time bound. For effective implementation of internal assessment every teacher has created score sheet. The students are also communicated the strong points and weak areas for improvement.

Examination department has made available one grievance form to the students. Students to fill all the required information in the same and to be submitted to the examination department back. The grievance form contains information of the students like name, class, roll number, eligibility number, PRN number and mobile number. The same form is reviewed by the examination department and action taken report is written on the same form. The time bound action is taken to solve the problem.

The college has gymnasium with required equipments. The College arranges required facilities for sports, games (indoor, outdoor). The college provides required area for indoor and outdoor sports. The college has a separate Kabaddi court, Volleyball court, Kho-Kho court. The college has archery set for the practice of the students. The library contineousely get upgraded according to latest curricula. Purchase and up gradation are being done as per demand of books. Executive Management Committee (Governing Body):

Samaj Shikshan Mandal is the executive management committee which is the apex body of the institution. It provides a clear vision and mission to the institution. The governing body council takes all the major policy decisions like the extension of the infrastructure, making recruitment decisions, articulating and

executing financial controls, mobilization and optimal utilization of the available resources etc.

The institution always abides by the rules and regulations of UGC, Maharashtra State Universities Act 2016 and Savitribai Phule Pune University, Pune. College management always recruits highly qualified and suitable staff. The posts available are widely advertised in leading regional and national newspapers. The interviews are conducted as per the rules after receiving and scrutinizing the applications. For the recruitment procedure, the college strictly follows conditions and rules laid down by statutory bodies and follows transparency during the process of recruitment.

College Development Committee (CDC):

The main role of the CDC is to provide clear and concise execution of policies as per the vision provided by the management. 6.3 Faculty Empowerment Strategies

6.3.1 The institution has effective welfare measures and Performance Appraisal System for teaching and non-teaching staff

Response:

The institution is concerned about the welfare of its entire teaching and non-teaching staff with its own limitations. The welfare schemes of the government are applicable to the faculties working under the aided section. Casual leaves, medical leave, maternity and paternity leave and drinking water etc. facilities are provided to the teaching and non-teaching staff. It also includes facilities like Employee's Provident Fund, DCPS, Salary Saving Bank Account Insurance, Medical Reimbursement and college uniform for the non-teaching staff. A medical first aid box is made available in the staff room for any medical emergency for the students or teachers. General medicine is also made readily available in the first aid box. Clean and hygienic sanitation facilities are available in the institution.

Performance Appraisal system:

API (Academic Performance Indicator): All teachers fill out the API forms for the respective academic year. The API forms are verified by the Principal as a chairperson, IQAC Coordinator and HOD of various departments as per UGC, Savitribai Phule Pune University, Pune and the Government of Maharashtra.

Confidential Report (CR):

The self-appraisal form is filled out by each faculty. The same self-appraisal form is validated by the Head of the Department and finally by the Principal of the institution. A confidential report is prepared by the principal relating to each teaching and non-teaching staff on the basis of the self-appraisal report and remark of the Head of the Department. The Confidential reports of all faculties are kept in personal files.

Assessment by the Students:

The student satisfaction survey (SSS) is conducted by sending the questionnaire to the students as per the NAAC guidelines. The report is also communicated to the staff for improvement.

Result Analysis:

For a better understanding of the course outcome and program outcome, a process of result analysis is carried out for individual subjects as well as the overall result.

Suggestion Box:

The quality improvement planning also includes taking suggestions and complaints from the students. There is a suggestion box outside the library where students and stakeholders can put their suggestions. Those suggestions are taken into consideration for the quality enhancement of the college by the IQAC.

Thus, performance appraisal, confidential report, assessment by the students, result in analysis and suggestion box are the main key input areas where the performance of the staff is measured.

Inferences drawn from the brainstorming sessions and feedback and analysis of responses form the basis for further planning and improvement of quality.

Non-salary grants are no more available for the grantee

institutions.

Annual fee collection is an important source of funds that are collected by following all the rules and regulations of the governing authorities. The institution also tries to mobilize the funds from funding agencies like UGC and Savitribai Phule Pune University, Pune under various schemes like NSS, Student Development Board, Earn While You Learn Scheme, Extra Mural and Life Long Education, Extension Programme and Quality Improvement program etc. The institution also contacts reputed and wealthy well-wishers to help the institution financially. Many such well-wishers also contributed to the infrastructure building of the institution.

The allocation of funds is always done by following the established procedure and processes of planning and prioritizing the needs of the institution. The most important needs of the funds are satisfied first by taking decisions in the College Development Committee and IQAC. The institution has formal purchase committee policy as per the Maharashtra University Act 2016. The allocation of funds is released only after sanction of the purchase committee with detailed scrutiny and discussion on the comparative statements of the various quotations. The institution follows a well-defined policy of resource mobilization and optimal utilization of the funds. The funds so utilized are also audited by the external certified auditor.

The Samaj Shikshan Mandal Amruteshwar Arts, Commerce & Science institution is operating in the hilly and rural area where the low level of higher education in general and girls students in particular is an issue. The main reason for low higher education level is low availability of the comutation, early marrige of the girls, farmer's family background etc. This institution is the only hope for the higher education of the girls students as this is the only single college in velhe tehsil. The issue of gender sensitization is well taken care by the college on this background.

- Regular curriculum covers the gender equity aspect: The regular curriculum covers the equity aspects related to gender equality. In the special subjects like history and politics covers the points of gender equality movements in India as a part of curriculum. Compulsory credit on Democracy, Election and Governance comprises this topic in detailed manner. Our teachers use classroom discussions as a pedagogical tool to understand and engage with gender aspects.
- In the last five years we have organised various programmes like state level webinar on gender equality, one day workshop on personal hygiene, State level webinar of guidelines of women redressal cell, health awareness programme for the girls students etc. These programmes carry a prominent and forceful message to promote gender equality in creative ways. Commerce faculty covers the subject of financial literacy and financial inclusion for women as a part of financial accounting subject.
- Our staff is committed to the gender equality goals and it reflected in their academic endeavours.
- One of the faculty member of our institution Dr. Seema Chaudhari has completed her Ph. D. on the subject "Contemporary Women Novelists: A Feminist Gita Haribaran, Manju Kapur and Anita Nair" and also delivered talk on the subject to the students and faculty members.
- The institution has formal gender sensitivity programme as a formal policy of the institution. The institution has also prepared the gender sensitivity report. Institutional Distinctiveness

Borge Scholarship Programme:

SSM Amruteshwar Arts, Commerce and Science College is situated in very remote and hill area in the ranges of Sahyadri mountains. All the students of the college are from the farmers' background. All the students are coming from the vernacular medium from their local village for the higher education in our college. Many students are coming from 10 to 20 km. distance from the college where no proper transportation facilities are available. Parents of the majority students are illiterate or marginally literate and agriculture is the main occupation of their family. With alignment of the vision, Mission and objectives of the institution; it is responsibility of the institution to support and encourage the bright students from the poor background. For this purpose, our college and parent organization Samaj Shikshan Mandal together follow unique programme for the help and support of the bright and needy students viz. "Borge Scholarship Programme".

Most of the families relay on the single income form the agriculture. Therefore, Sanstha and college motivates and encourage them by providing scholarship in Cash Price to the needy and bright students. Some of the eminent personalities of management like Hon'ble Pradip Phadke, of the Sanstha and college professor like Dr. Mahadev Dongare and Dr. Vijay Kadam provide scholarship to the needy and bright students every academic year. Students also getting scholarship for the individual subjects.

The first, second and third rank holders from all the faculties i.e. B. A., B. Com, B. Sc. are rewarded by the scholarship. Also, students form 10th and 12th from the Velhe tehsil are also rewarded by the college. Cash price of ? 700 for the first rank holder, ? 500 for second rank holder and ? 400 for the third rank holder is given. For the year 2016-17 total 44 students were benefited from the programme. For the year 2017-18 total 45 students were rewarded by the institution. In the year 2018-19 total 61 students were benefited from the programme. In the year 2019-20 total 71 students were benefited from the Borge

Scholarship Programme. Due to covid pandemic the programe was not arranged for the next two years.

This programme is very useful for the students are they not only get the cash benefit and memento as support for their education purpose but also the zeal, energy and motivation to perform better year after year.

As our students are from the weaker financial position the college is following Institutional Social Responsibility thorough various ways. Some of the distinctive activities following by the college are as follows:

- 1. Subsidize Transportation facility for the girls students form remote area. : As an Institutional Social Responsibility initiative college and Samaj Shikshan Mandal Sanstha has arranged subsidized transportation facility for the girls students from the remote areas to reach to the college. Half of the expenditure is born by the Sanstha for the same. This scheme is very much beneficial to the girls students who's dream of higher education is only possible due to transportation facility arranged by the Sanstha to their local point.
- 2. Green Environment and Clean Environment Drive by the College: Green Environment and Clean Environment Drive is another unique practice of an institution. College is surrounded by the most famous tourist attraction like Rajgad and Torna fort of Chhatrapati Shivaji Maharaj. It is great historical place and good amount of footfall by the history lovers and tourists every year. It creates good amount of plastic waste on the forts. Our college students come up with an idea which was implemented by the college for the Green and Clean Environment Drive. College has placed one big container for the plastic collection, which includes dry plastic bottle and plastic wrappers that our students collect from the area and put it into container. College periodically collects the waste together to handover it to the local gram panchayat who further responsible for the scientific disposal of the same. College also arrange cleaning activity on the forts. College also appeal to the tourist to collect the plastic waste and clean the fort.
- 3. **Village Adoption for Development Scheme:** The institution has unique practice of adoption of the village under the National Service Scheme (NSS) whereby institution adopt the village for the overall development of that village for the next 3 years. NSS arranges residential camp in the same adopted village for the 3 years and try to solve social problems of that village. For last 3 years "Pimpari village" was adopted which shows remarkable change.
- 4. Education awareness Drive: Institution follows very unique practice of the educational awareness drive as all the students are from the farmers' family and illiterate or marginally literate family background. Some of the parents want their children to work for their family and earn bread and butter rather than to continue education. This is more specifically true for the girls students. Some of the parents also wish to marry their girl early rather that continuing their higher education. On such a background; college teachers especially teachers from the science faculty visit village to village and home to home for creating the education awareness amongst the parents as well as the students for higher education.
